The Ambassador of the Czech Republic to Serbia, H.E. Mr. Tomáš Kuchta will open the event.

In the introductory part, the representatives of TI Czech Republic Jana Stehnova and TS Zlatko Minić will talk about the transparency of data on the financing of the campaign in progress. Tomas Hidecek, a representative of TI-CZ, and a representative of the Serbian Agency for the Suppression of Corruption will give opening statements on the control of the financing of the election campaign. Jan Dupak, a representative of TI-CZ, and Zoran Stojiljković, a professor at the Faculty of Political Sciences, will speak about limiting the total costs and individual revenues of the campaign. Ondrej Cakl (TI-C) and Nemanja Nenadić (TS) will give opening statements on the direct third-party financing of the election campaign.

Invited are representatives of the relevant institutions which have a certain role in the financing of political activities and control of compliance with related regulations, especially when it comes to election campaigns or the development of regulations relevant to this area; representatives of political entities who participated in the last parliamentary elections and political parties and active political movements participating in the dialogue on election conditions; representatives of non-governmental organizations; representatives of scientific and educational institutions; relevant international institutions and media representatives.
